01. Name of work: Balance works for approach road from Kanthan to Dugga Village (Length 28.0 km) on Katra- Dharam Section of USBRL project, District Reasi in Jammu & Kashmir. **02. Approx. cost of work:** Rs. 11.42 Crores **03. Earnest Money Deposit:** Rs. 7.21 Lakhs (**Tenders received without earnest money in the form and value specified in the tender document will be summarily rejected**) **04. Completion Period:** 18 months **05. - b) As a proof of sufficient financial capability and organizational resources, contractor should have received the total payments against satisfactory execution of all completed / on going works of all types (not confined to only similar works) during the last three financial years and in the current financial

year (Up to the date of opening of the tender) of a value not less than 150% of the advertised cost of work, including the cost of cement and steel.

The similar nature of work is defined as under:

“Work carried out in the form of earthwork, road work, Protection works, RRM and CC/RCC etc will be considered.

“JV/Consortiums/MOUs shall be considered.”
