TERMS AND CONDITIONS FOR HIRING VEHICLE

01. a) The vehicle to be utilized by the Konkan Railway Corporation Ltd. should be non A/C Toyoto/Tata/Mahindra/Sumo or of similar make (Diesel) having minimum seating capacity of (6+1) with monthly limit of 2500 Km.per month having permit of commercial use (Taxi permit/Tourist permit with all features and fittings with Euro II standards and should be of showroom condition preferably white colour with valid registration of October 2003 or later, comprehensive insurance and PUC. The same vehicle with sufficient fuel should be supplied and maintained every day preferably with the same driver.
- b) The vehicle shall be provided at Chiplun head quarter of AEN's special works.
- c) The tenderer shall quote separately for each one of the above vehicle.
02. The inner and outer condition of vehicle should be clean and hygienic fitted with good quality of fans, lights, clean seat covers and other required accessories.
03. No payment will be admissible if the vehicle fails during the trip and immediate alternative arrangement is not provided by the firm. In the event of breakdown of the vehicle in route the responsibility to transporting the incumbent of the vehicle to his destination shall be borne by the firm.
04. The driver attached to the vehicle should be smart, well behaved, polite, well mannered and in a clean uniform. In case the driver with the vehicle fails to report at the required time/place, Corporation may arrange a vehicle on its own and deduct the charges of arranged vehicle from the bills of the firm. The driver shall be provided with mobile phone.
05. Bill/Payment bill should be submitted in the name of Sr.Regional Engineer through the concerned officer alongwith vehicle diary every month. Payment will be made within 15 days after receipt of the bill.
06. Normal time of working will be 08:00 hours to 20:00 hours. The timing may be varied based on actual requirement. Driver shall report to officer at designated place.
07. Normal running would be about 2 500 km. per month.
08. The vehicle shall generally be used within Ratnagiri Region i.e. Roha to Madhure of KRCL. However, in case of outstation trips also the same vehicle may be taken for which payment within the monthly arrangement shall be made depending upon the duty requirement.
09. The driver shall normally be given weekly off on Sundays. However, in case vehicle is utilized on Sunday, a compensatory rest or overtime to the Driver shall be given.

10. The Firms shall be responsible for and shall pay any compensation to his employees payable under the Workmen Compensation Act 1923 and 1933 and the amendments thereto for the injuries caused to the drivers. The firm shall be responsible for and pay the expenses for providing medical treatment to any of their driver who may suffer any bodily injury as a result of any accident.
11. The firm shall indemnify Konkan Railway Corporation Ltd. against all losses or all claims, damages, insurance and any liability which may arise under the Motor Vehicle Act or Workman Compensation Act or any other Act or statue having bearing over the services and for engagement of workman, directly or indirectly for performance of work under the contract.
12. Hours and Km. will be treated from reporting Km. Reporting/releasing the vehicle to by the concerned officer from respective KRCL Office. The kilometre on account of travel to and from the firm's garage shall not be payable.
13. Log book to be maintained detailing therein reporting Km. Reporting time, releasing km. releasing time etc. which will be countersigned by the user and the Driver with name.
14. The rate is on per month basis and includes all applicable charges for hiring of vehicle with Driver. No additional charges towards night charges cancellation charges, driver's food allowance etc. are permissible.
15. Termination of Contract : The contract is liable to be terminated after 7 days notice, in case the services are found unsatisfactory or services are not required by KRCL during contract period. No claim will be entertained due to termination of contract during contract period.
16. Period of contract: The services are required for the period 10 months from the date of issuing of acceptance letter.
17. The firm shall have to provide (keep along with vehicle) extra wheels, jack proper tools and tackles one torch, fan belts, First Aid Box, fire extinguishers and any other item as required by law.
18. Penalty: In case any vehicle(s) is/are withdrawn from duty by the contractor or if the contractor fails to provide a vehicle or the vehicle(s) supplied is not in acceptable condition, no payment shall be made to the contractor for that day against the vehicle(s) and Konkan Railway Corporation Ltd. shall have the discretion to make an alternative arrangement at the risk and cost of contractor. Any additional expenditure incurred by KRCL in making such alternative arrangement shall be recovered from the contractor's bills. Normally the alternative arrangement would be made if the vehicle has not reported even after 1/2 hour (half hour) of the reporting time. Also, a penalty of RS.100/- per day per vehicle will be recovered from the contractor for failure to supply the vehicle(s) for any day as per conditions stated above. In case of late reporting exceeding 15 minutes a penalty of Rs. 25/- per hour or part thereof limited to maximum Rs.100/- per day will be recovered.

19. Rate quoted by the contractor shall remain unchanged throughout the entire period of the contract.
20. Insurance : The vehicle (s) provided to the company at any point of time during the contract period shall be covered by comprehensive insurance to be arranged by the contractor is due performance of his obligations under this contract.
21. Parking / toll charges if any will be reimbursed on monthly basis as per actual on production of the original paid vouchers / receipts.
22. Statutory formalities : All formalities in respect of R.T.O. shall be completed by you regarding registration of vehicle, payment of taxes, having validity of commercial use i.e. Taxi permit, road permit etc. comprehensive insurance of the vehicle is mandatory and should be done with insurance authorities. Necessary certificate " Pollution within permissible limit" shall be obtained in the intervals as prescribed in Statue.
23. No other use of vehicle : The vehicle once hired by the Corporation normally should not be used for any other purpose during off days and beyond duty hours for any other purpose.
24. The successful tenderer should submit copies of relevant documents i.e copy of RC book, insurance, PUC certificate.
25. Jurisdiction : Any dispute regarding terms and conditions or any other point, the decision of Sr.Regional Engineer/Ratnagiri will be final and binding on you.
