CORRECTION SLIP TO CLAUSE 40.2 OF GENERAL CONDITIONS OF CONTRACT OF KRCL

VARIATIONS IN QUANTITIES

- 40.2(a) Unless otherwise specified in the Special Conditions of contract, the accepted variation in quantity for each individual item of the contract would be upto 25% of the quantity originally contracted, except in the case of foundation work. The contractor shall be bound to carry out the work at the agreed rates and shall not be entitled to any claim or any compensation whatsoever upto the limit of 25% variation in quantity of individual items of works.
- 40.2(b) In the case of earthwork the variation limit of 25% shall apply to the gross quantity of earth work and variation in the quantities of individual classifications of soil shall not be subject to this limit.
- 40.2(c) In the case of foundation work no variation in limit shall apply and the work shall be carried out by the contractor on agreed rates irrespective of any variation.
- 40.2(d) For the first 15% increase in the value beyond 25% of agreemental value, the rates should be reduced by 2% in the incremental value of the agreement.
- 40.2(e) For the next 10% increase in the value a further reduction in the rates by additional 2% in the incremental value of agreement to be carried out.
- 40.2(f) Execution of quantities beyond (+)50% of the overall agreemental value should not be permitted and if found necessary should be through fresh tenders or by negotiating fresh rates with existing contractor.

- 04 samples of vetivery grass should be planted in each hole. If it is found less than 04, no payment will be made for such type of work.
- The spacing of vetivery is 0.20 x0.50 meter i.e distance between two sapling is 0.20 meter and distance between two rows is 0.50 meter. After layout, the holes of 25 mm dia and 100mm deep shall be dig with the help of rods without disturbing land surface.
- After preparing the hole ready for plantation, Vetivery grass are planted in the hole by 100 mm deep. Before the plantation, the root of the grass should be dipped in the Humic Acid. After plantation holes shall be pressed by hand.
- Following fertilizer are to be filled in the hole:
  - Bio mass - 50 gm/per hole
  - Murit of Potash - 5 gm/per hole
  - Single Super Phosphate - 10 gm/per hole

- 01 Scope of work : Works mainly involved in this tender are for supply and plantation of vetivery grass sapling in cuttings under SEN/Kankawali section.
- a) Supply and Plantation of vetiveri grass sapling on cuttings slope including making hole of size 25mm dia & 100 deep by suitable rod as per requirement at site in all kind of soil, murum, hard murum and laterite soil with contractor's own labour with contractor's own chemical fertilizer/ bio-mass as per below. At least 4 vetivery grass sapling should be used in each pit. If it is found that the sapling are used less than 4 Nos, payment will not be made and summarily rejected.  
Following fertilizer are to be filled in the hole:
- i) Bio mass - 50 gm/per hole
  - ii) Murit of Potash - 5 gm/per hole
  - iii) Single Super Phosphate - 10 gm/per hole
- b) The spacing of vetivery is 0.20 x 0.50 meter i.e distance between two sapling is 0.20 meter and distance between two rows is 0.50 meter. After layout, the holes of 25 mm dia and 100mm deep shall be dig with the help of rods without disturbing land surface.
- c) After preparing the hole ready for plantation, Vitivery grass are planted in the hole by 100 mm deep. Before the plantation, the root of the grass should be deep in the Humic Acid. After plantation holes press by hand.
2. Period of Completion : One Month(including monsoon) from the date of issue of acceptance letter.
3. Time limit : Time is the essence of the contract and the tenderer /contractor is required to complete the work within the period of completion.
4. Period of maintenance : One year after completion of the work.
5. As per the provision of EPF & MP Act, 1952, contractor who is engaging labour has to deposit PF amount with EPF authorities. It should be ensured that, PF registration details of the contractors are available and included in the tender document. No payment should be arranged in case of PF registration number is not made available.
- In case the contractor has not registered with EPF authorities, but is liable for payment of PF amount, the amount should be recovered from due bills and paid to EPF authorities quoting the PF registration number of KRCL. Detail instructions and compliance certificate to be submitted are enclosed in Annexure-A.
6. Bio-mass and chemical fertilizer required for the works will be arranged by the contractor. Contractor shall arrange to supply bio-mass and chemical fertilizer at once and transport to the workspot as per requirement for plantation at his own labours.
7. Payment Terms & Conditions :
- i) 50% payment will be released after survival of the plant at the end of one month after plantation.
  - ii) Balance 50% payment will be released after one year after completion of the work for surviving plants.

8. Approximate locations and quantities are indicated in Annexure-B. The locations and quantity may vary as per site conditions for which no claim will be entertained due to change of locations, addition or deletion of locations or quantities etc.
9. Before starting the work, contractor should take the layout of works to be carried out in the cutting from concerned Engineer-in-Charge.
10. Site order books, progress register and material issue register shall be maintained at site and entries will be recorded on day to day basis in the registers and signed by jointly by Corporation Supervisor and by contractor or his authorised representative.
11. Proper care should be taken to protect the track as well as OFC cables from damage during the execution of works. If damage is occurred due to negligence of the contractor, penalty of Rs.1.00 lakh or actual whichever is more on each incidence shall be levied and binding on the contractor.
12. The materials issued to the contractor shall be properly secured and the contractor is responsible for its safe custody. The contractor shall take all the precaution to prevent its damage from fire, floods etc. In case of loss of Corporations materials, the Corporation will recover the cost as per extent rule.
13. After completion of work, the site shall be cleared of all muck and debris within period of 10 days from the date of completion of work. If contractor fails to do so, the muck/debris will be got removed by another agency and the cost will be recovered from the contractor.
14. The Engineer-in-charge shall approve the methodology proposed to be adopted by contractor, with a view to ensure safety of trains, passengers and workers and he shall also ensure that the methods and arrangements are actually available at site before start of the work and the contractor's supervisors and the workers have clearly understood the safety aspects and requirements to be adopted/followed while executing the work. There shall be an assurance register kept at each site, which will have to be signed by both i.e. Railway Supervisor or his representative as well as the contractor's supervisor as a token of their having understood the safety precautions to be observed at site.
15. It shall be clearly understood that the contractor is personally responsible for any omission and commission on the part of men engaged by him. In case of any damages to railway/public property or injurious to the travelling public on account of failures of contractor to adhere to safety or resulting in an accident, the cost of damages will be recovered from the contractor from this work or other on going works. In addition, the contractor will also be liable for criminal prosecution as per extent rules.
16. Before tendering, tenderer/contractor shall inspect the site and get himself acquainted about availability of labours, materials, approach road, working condition etc.

## EPF CLAUSE :

- i) The contractor shall be liable to pay before the due date his contribution, employee's contribution and other administrative charges as per provisions of the Employees Provident Fund Act as amended from time to time, in respect of all the staff and labour employed by him for the execution of the contract. In the event of his failure to follow the above provisions, the Corporation has to pay the said amount of contribution as assessed to the Provident Fund Commissioner and the Corporation will recover from the contractor the amount paid to the Provident Fund Commissioner, out of the sums due and payable to the contractor.
- ii) In such case of failure on the part of contractor, contractor shall indemnify and save harmless the Corporation from and against all actions, suits, proceedings, losses, costs, damages, charges, claims and demands fo every nature and description brought or recovered against the Corporation by reason of any act or omission of the contractor, his agents or employees in connection with complying the provisions of the Employees Provident Fund and Miscellaneous Provisions Act, 1952 as amended from time to time. All sums payable by way of compensation/penalty/damages/interest on the outstanding amounts payable by the contractor shall be considered as reasonable and be payable by the contractor to the Corporation immediately and if the contractor does not pay the amount immediately the same will be deducted from the security deposit or earnest money or any other amount available with the corporation or any moneys payable to the contractor by the Corporation.
- iii) Contractor should submit a compliance certificate along with the details of employees and recoveries made to the Konkan Railway Corporation as per the proforma enclosed hereunder every month within seven days of the close of every month as per the provisions of the Employees Provident Fund and Miscellaneous Provisions Act, 1952 as amended from time to time.
